4. ARPA/STATE FISCAL RECOVERY FUNDS (Discussion)

Selectman Azalea Cormier read the answers to Vivian Wadas' questions regarding ARPA presented to the Board in writing at the July 5, 2023 meeting. Town Manager Cameron Hinkley provided Chairman Robert Hand further information regarding the ARPA funds so he could further explain those answers.
